## E. RICHMOND HILL HOCKEY ASSOCIATION TERMS AND CONDITIONS

1. No player under the age of eighteen (18) may be registered without his/her parent or guardian's consent.
2. No player will be allowed to play without being properly registered.
3. House league and local league teams may have more than 1 goalie per team.
4. All parents who have players registered to ORD local league program agree to abide by the Simcoe Region Local League (SRLL) policies and procedures. To view SRLL policies and rules go to: [srll.ca](http://srll.ca)
5. In order to be compliant with the SRLL balancing rules, R.H.H.A. and/or ORD reserves the right to move local league players to ensure a balanced division. In extreme cases balancing can be done as late as December. In cases of disputes, a pro-rated refund will be available in conjunction with our Refund Policy (below)
6. R.H.H.A. reserves the right to move house league players in order to provide a fair and balanced house league program. In cases of disputes, a pro-rated refund will be available in conjunction with our Refund Policy (below)
7. Enrolment is limited. ALL REGISTRATIONS are based on a first come first served basis. This includes players registered in prior years.
8. R.H.H.A. and/or ORD reserves the right to alter additional charges to the local league program based on circumstances.
9. R.H.H.A. has the right to use the likeness of all players playing within the R.H.H.A. for promotional purposes without further consent.
10. Due to the nature of the game of ice hockey and all ancillary matters related thereto, injury or death may occur. The undersigned (on behalf of him/herself, his/her heirs, executors and assigns) hereby releases the R.H.H.A., including its members, directors, officers, agents and employees, as the case may be, from all such liability arising there from.
11. Due to the size of our association we DO NOT honour friend, team or coach requests.
12. I acknowledge R.H.H.A. has a Parent/Spectator Code of Conduct (can be found on website) and will adhere to the policies in place. I also acknowledge failure to comply with the Code of Conduct can result in dismissal from our arenas and in severe cases de-registration of my child(ren).
